- I agree to pay the rates for services that are in effect at the time my dog/cat attend Off The Leash Pet Care, LLC., I am aware that extra charges may be incurred, and I agree to pay them at time of pick up. _____, _____ initials.
- I understand that on entering Off The Leash Pet Care, LLC., my pet will be examined for fleas. If fleas are found, immediate pick up of my dog/cat will be required. I have read and acknowledged the admission policies pertaining to vaccinations that are required and “not required” for participation in Off The Leash Pet Care, LLC services. - If my dog/cat participates in playgroup, daycare or any other services, I understand that an interactive play setting is not without some risk of injury, that despite all the dogs/cats appearing healthy and being handled with the greatest of care and foresight, dogs/cats are not always predictable and the unexpected and the unexplained may occur. - If my pet appears to be ill or injured, I authorize Off The Leash Pet Care, LLC. to engage services of a veterinarian at my expense, to give other requisite attention, and to make whatever decisions are required for my pet’s veterinary treatment. I further acknowledge that even if my dog/cat is vaccinated for Bordetella (Kennel Cough) there is a chance that my dog can still contact Kennel Cough, I agree NOT to hold Off The Leash Pet Care, LLC., responsible if my dog(s) contracts Kennel Cough. I acknowledge that the Kennel Cough vaccination is not a guarantee of immunity and with or without vaccination in groups of dogs Kennel Cough is an assumed potential risk to my dog participating in Off The Leash Pet Care, LLC., activities. ____, ____ initials.
